Inside Park Vendor Setup and Parking Map Instructions

Tent Exhibitors & Vendors Inside Centennial Park Only

1. Enter 18th Street from 8th Ave on the West side of the Park and Check-in on 18th Street with CSF Staff. After you check in, drop off your Items first and then you will proceed to exit Left on to 9th Ave and 18th Street turn left going west on 9th Ave and Park your Vehicles in any Parking Area around the Park. **DO NOT PARK YOUR VEHICLES IN THE SET UP AREAS, DO NOT LEAVE YOUR VEHICLE SITTING IN THE STREET! IF YOU LEAVE YOUR VEHICLE PARKED IN ANY SET UP AREA YOUR VEHICLE WILL BE TOWED. NO PARKING ON EITHER SIDE OF 19 St N OR YOUR VEHICLE WILL BE TOWED!**
2. **YOU MUST DROP OFF YOUR ITEMS THEN PARK** in the Parking lots shown on Map. **DO NOT SETUP WHILE UNLOADIN THIS WILL CAUSE A BACKUP And block the street.**

1. Coming from Palm Ave enter on 19th Street and 9th Ave proceed to check in with CSF Staff. After you check in, drop off all your Items first in your designated Vendor Space and then you will exit on 9th Ave and **Park your Vehicle in any Parking Area around the Park. DO NOT PARK YOUR VEHICLES IN THE SET UP AREAS, DO NOT LEAVE YOUR VEHICLE SITTING IN THE STREET! IF YOU LEAVE YOUR VEHICLE PARKED IN ANY SET UP AREA YOUR VEHICLE WILL BE TOWED. Food Truck and Trailer Vendors Only

1. Enter 19th Street from 8th Ave on the East side of the Park and Check-in at the corner of 19th Street and 8th Ave with TOL Staff You then proceed as directed to your designated Space and park your Food truck or Trailer on 19th Street.
2. Food Trucks and Trailers with windows that open on the Driver's side must park on the east side of 19th Street Food Trucks and Trailers with windows that open on the Passenger side must park on the west side on 19th Street Food.
3. **Food Trucks must park in their space and Food Trailers must Drop off their Trailer and proceed to exit up through 19th Ave and Palm and park your Vehicles in any Parking Area around the Park.**
DO NOT PARK YOUR VEHICLES IN THE SET UP AREA, DO NOT LEAVE YOUR VEHICLE SITTING IN THE STREET of the Setup Area! NO PARKING ON EITHER SIDE OF 19 St N OR YOUR VEHICLE WILL BE TOWED!
